This Public Educational & Charitable Trust Deed is made at Delhi on 02 Nov 2011, John Vianney Sharma (Age 53yrs DOB- 01/01/1959) S/O Late Mr. S P Sharma R/O B-14, S-3, Bharat Apartment, Vivek Vihar Phase-I, Delhi - 95; hereinafter called the 'SETTLER' (which expression shall unless excluded by or repugnant to the subject or context be deemed to include his heirs, executors, administrators, assigns and representatives) of the ONE PART and...

- (1) Mr. John Vianney Sharma (age 53yrs DOB - 01/01/1959.) S/O Late Mr. S P Sharma R/O, B-14, S-3, Bharat Apartment, Vivek Vihar Phase-I Delhi - 95;
- (2) Mr. Shobha Sharma (age 50yrs DOB - 21/06/1961.) W/O Mr. John Vianney Sharma R/O. B-14, S-3, Bharat Apartment, Vivek Vihar Phase-I Delhi - 95

... Hereinafter jointly called the 'TRUSTEES' of the OTHER PART.

WHEREAS the Settler is desirous to establish a Public Educational & Charitable Trust, for general welfare of humanity. The Trustees have at the request of Settler agreed to act as Trustees of these presents upon the terms and provisions hereinafter contained.

- [1] In order to effectuate the said object of creating and establishing a Public, Educational & Charitable Trust, the Settler has delivered to and made over to the Trustees a sum of Rs. 1,000/- (Rupees One Thousand Only) with intent to part with all his rights, title and interest claim therein and vest the same in the Trustees to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represent the Trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the Trust (hereinafter referred to as 'THE TRUST FUND') for the charitable objects and purposes and uses hereinafter expressed with the powers and on the terms and conditions herein contained of the concerning the same.

[2] The NAME of the Trust shall be :

" ST MARY'S EDUCATIONAL & CHARITABLE TRUST "

- [3] The OFFICE of the Trust shall be situated at: **B-14, S-3, Bharat Apartment, Vivek Vihar Phase-I DELHI - 95**, which may be changed from time to time to such other place or places as the Trustees may deem fit and proper at their discretion.
- [4] The Trust could have its unit offices at any place in India and Abroad.
- [5] Those who are Trustees for the purpose and declares that Founder (MR. JOHN VIANNEY SHARMA) will continue to be the Executive Trustee of the Trust and one of the Trustees for his life time.
- [6] The objects of the Trust shall be:
- To provide sound education (including Computer education) to children of all communities irrespective of their race, religion, caste or creed in general and to prepare them to become mature and responsible citizens of the country through all-round physical, intellectual, academic, moral and spiritual development based on valued derived from the life.
 - To start, establish, run, take over or manage and maintain schools, with an object to provide sound pre-primary, primary, Middle, secondary, senior secondary and higher education to children by seeking recognition and affiliation from the education departments and concerned Govt. Authorities.

- c) To conduct research in education and other disciplines on the different subjects relating to education.
- d) To open, found, establish, promote, set up, run, maintain, assist, finance, support and/or aid and help in the setting up the different kinds of technical/non-technical schools, engineering colleges, medical colleges and other establishments or institutions for advancement of all kinds of education and knowledge (also get permission from the competent authority/department, if required).
- e) To appoint Managing Committee including its Chairman, Manager and Members of school.
- f) To arrange and manage the vocational training institutions in Typing, Short Hand, Computer, Fine Arts, Crafts, Music, Painting, Dancing, Yoga, Physical Education and in other professional training subjects/courses.
- g) To open, found, establish, promote, set up, run, maintain, assist, finance, support and/or help the various charitable, educational, technical/non technical, industrial, vocational and agricultural institutions.
- h) To do best efforts for the promotion of medical education and by running various schools, colleges and other medical research centers, after getting the approval from the competent authority.
- i) To promote literacy, cultural and other social activities by Awareness Programs, Adult Education Classes, Sarv Shiksha Abhiyan, Lectures, Essay Competitions, Exhibitions, Symposiums, Cultural Programs, Press Conferences and Seminars.
- j) To provide food, cloths, medical aid, stationary, libraries, laboratories, reading rooms, hostels, play grounds, swimming pool and other possible facilities to students.
- k) To establish, support, finance, manage and develop such out of school activities for the children where they could have the benefits and joy of participating in sports, games and other artistic activities like painting, music, dance, wood & clay work and also arrange the educational trips.
- l) To institute scholarships and help to deserving students and to institute and award prizes for their excellence academic performance.
- m) To provide free/concessional education to the hopeless, poor and needy children specially to the handicapped children.
- n) To borrow or receive money (with interest or without interest) and upon such terms and conditions as are approved by the Governing Body of the trust.
- o) To engage, employ or hire appropriate staff, workers, legal experts and other professionals, attorneys, managers and agents for the work and furtherance of the aims and objects of the trust and to pay their wages, salaries, stipends or fees.
- p) To organise Seminars, Meetings, Press-Conferences and other lawful gatherings from time to time.

- q) To receive financial and non-financial assistance from Govt. Non Govt. Organisation, International Agencies, Banks and any other legal entity or individual. To accept donations, grants, presents, gifts, and other offerings in the shape of moveable and/or immovable properties for the attainment of the aims and objects of the trust.
- r) To invest the moneys of the trust not immediately required, in Mutual Funds, UTI, Securities or Deposits as are permitted by the law for the time being in force.
- s) To purchase/acquire lands and/or the buildings in the name of the trust for the upliftment and fulfillment of the Aims of the trust.
- t) To erect, construct, alter, maintain, sell, lease, mortgage, transfer, improve, develop, manage and control all or any part of the property or the building of the above trust, necessary or convenient for the purpose of the attainment of the Aims and Objects of the trust
- u) To publish Souvenir and other literature in the different languages and on the different subjects which may be useful for general welfare of the general public.
- v) To do such other things/acts/activities which are necessary and which may be incidental or conducive to the attainment of any of the object of the trust.
- w) All the acts/activities/programs shall be Non Profitable and shall be done on 'No Profit-No Loss' bases.
- x) trust will invest its money and funds according to Sec.-11(5) of Income Tax Act, 1961.
- y) All the incomes, earnings, moveable/or immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past members of the trust or to any person claiming through any one or more of the present or the past members. No member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of this membership.
- z) 1. To hold and manage the assets and properties acquired/inherited or purchased by the Trust as may be necessary or appropriate for the achievement of the objectives of the Trust.
2. To erect, construct, alter, maintain, lease, mortgage, transfer, improve, develop, manage and control all or any part of the property or the building of the above Trust, necessary or convenient for the purpose of the attainment of the Aims and Objects of the Trust.

3. To publish Books, Charts, Illustrations, Journals, Magazines, Periodicals, News Letters/Papers and other publications in the different languages and on the different subjects for achieving the objective of the trust
 4. To assist and co-operate the other Associations, Trusts, and the various N.G.Os. whose aims are same like this Trust.
 5. To do such other things/acts/activities which are necessary and which may be incidental or conducive to the attainment of any of the object of the Trust.
 6. The activities and the branches shall spread all over in India and also in the different countries of world as per law applicable in India.
- [7] The founder shall appoint any employee i.e. Manager, supervisor, legal advisor and legal assistant, accountant, cashier, peon, chowkidar etc. He has also the powers to terminate the services of any staff as he may deem fit and proper for the benefit of the Trust.
- [8] During the life time of Founder, he can appoint his nominee and after his death the appointed nominee and in case none is appointed then the legal heir will enjoy all the rights of the founder as presently the Founder is enjoying. This process of nomination or successor shall continue till the working of the Trust. To repeat the Settler or the nominee(s) shall continue to hold all those powers at present enjoyed by the Settler.
- [9] The Founder/ JOHN VIANNEY SHARMA will be the absolute in-charge of the Trust and will exercise all the Discretionary and sovereign powers.
- [10] It is hereby declared that no part of the Trust property or its income shall be applied for any purpose other than the objects of the Trust as understood under the Income Tax Act, for the time being in force, and the surplus funds if any of the Trust shall be invested as per the provided the Income Tax Act.
- [11] The number of the Trustees shall not be less than two and not more than **Eleven**. The Trustees shall be Trustees for their life time but any Trustee may resign by giving in writing to the Co-Trustees. Appointment of Trustee(s) shall be only with the final approval of Settler/his Nominee(s) or the Successor(s).
- [12] The general management and control of the Trust properties and its affairs shall be vested in the Trustees and the Trustees shall have power to do the

all such acts as may be considered necessary for the benefit of the Trust and/or management of its properties and affairs. Veto Power shall always remain with Settler, Nominees or the Successor(s).

[13] All the trustees (including Executive trustee/founder) shall form the 'BOARD OF TRUSTEES' and all the decisions shall be taken in the meeting of Board of Trustees called from time to time. Without prejudice to any of the powers that the Trustees may have under any law for the time being in force or to their general powers for management, the Trustees shall have the following powers:

- a) To manage the Trust, the Trust fund, Trust Property and other affairs relating to the Trust and to do all acts, deeds and things necessary for the preservation, maintenance and management thereof and the affairs relating thereto or connected therewith, including the making of Rules and Regulations from time to time.
- b) To apply any part of the Trust fund in acquiring moveable/immovable properties and ~~sell~~, mortgage, alienate or otherwise ~~dispose of~~ the same as they may think fit and proper.
- c) To take on rent or lease, purchase or construct building and to construct, add, alter demolish, maintain, ~~sell~~, ~~dispose of~~, alienate or otherwise deal with any property moveable or immovable comprising the Trust Fund, for the achievement of the objects of the Trust.
- d) To let out, demise any moveable or immovable property comprised in the Trust fund for such period and at such rent discretion may think fit.
- e) To acquire purchase, vary, sell convert, change, transfer, transpose or otherwise deal with all or any of the investments including shares, stocks, debentures, Govt. Securities belonging to the Trust or representing the Trust Fund and to re-invest the same as the Trustees may deem fit and proper in accordance with the provisions of Income Tax Act.
- f) To apply and get registered under Sec. 80-G of the Income Tax Act.
- g) To accept donations, contributions, gifts and/or other grant-in-aid either in money or in kind.
- h) To enter into any contract and borrow money for the purposes of the Trust and management of its properties and assets.
- i) To open account(s) and give directions to transfer, endorse and sign government securities, promissory notes, shares, debentures, securities, instruments etc. and all these accounts shall be operated by the Trustees jointly and/or severally as decided by them but the decision of the Founder/Nominee(s) or the Successor(s) shall be final.

- j) To appoint Sub-Committees comprising one Trustee or more for carrying out the objects and purposes of the Trust or matters connected with the Trust and/or its affairs.
- k) To institute suits, actions and legal proceedings, to prefer appeals, to make applications or petitions, and to give affidavits, wherever necessary and to defend or compound, compromise, abandon, submit to arbitration or otherwise settle any suit, action claim, legal proceedings, appeal, demand or dispute relating to the Trust matters.
- l) To keep proper accounts of the Trust Fund and its property.
- m) To apply to whole or any part of the Trust Fund (corpus and/or income) or property for the objects and purposes of the Trust and to set apart the whole or part of the income of the corpus or part thereof for any of the objects of the Trust.
- n) To amalgamate the Trust with other institution, association, Trust, or organisation having Public Charitable objects and purposes with the consent of two third of Trustees in writing.
- o) To nominate, appoint and constitute attorney(s), legal practitioners, agents etc. and to delegate the duties and powers vested in them (Trustees) with regard to the management of the Trust property including starting or defending of legal proceedings or for opening or operating upon accounts with any bank(s), person(s), firm(s) or to do such other acts and duties relating to or connected with the Trust property as may be deemed necessary.
- p) To appoint/nominate patrons and to give such other designations to various persons extending help for the running or for the case of the Trust.
- q) And generally to do all acts, deeds and things as may be necessary for administration of the Trust.

[14] The Trustees will not be entitled to receive the remuneration as Trustees but may reimburse themselves of all expenses actually incurred by them in connection with Trust or their dues thereto.

[15] The Trustees may from time to time, frame Rules for the conduct of the administration of the Trust and regulating the meetings of Trustees. In the absence of such regulations:-

- (i) all the matters will be decided by the majority and the quorum for the meeting shall be two third,
- (ii) a resolution circulated to all the Trustees and signed by the majority of such Trustees shall be as valid and effectual as resolution duly passed at a meeting of the Trustees.

- [16] That regular accounts will be maintained relating to all receipts, payments, income, expenditure or any property or liabilities relating to the Trust. Further the accounts of the Trust will be audited by a qualified accountant.
- [17] The Board of Trustees shall be entitled to sue in the name of Trust and may similarly be sued in the name of Trust.
- [18] The dissolution of the Trust may be affected by a Special Resolution passed by a majority of three-fourth of the Trustees present at the Special meeting convened for the purpose and with the consent of the president of the Trust there remains after the Satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid or distributed amongst the Trustees of the Trust, but shall be given or transferred to some other like Institutions having same Aims and Objects to be determined by the Board of Trustees at or before the time of dissolution.
